I PAID MY POST DUES—WHY AM I GETTING ANOTHER DUES RENEWAL NOTICE?

Well, Department Headquarters has received numerous call regarding members getting renewal notices after they have paid their Post dues. Therefore, I thought we should spend a few moments examining this issue and trying to resolve any misunderstandings relative to Department's receipt of membership dues. Please remember that our dues process has several steps (time based) once a member pays his/her dues at the local Post. Everyone has to complete their responsibilities for the process to work.

First, it's important for everyone to understand that

a member's dues are not officially paid until the dues are received and processed at National Headquarters in Indianapolis.

Currently, Louisiana has five (5) renewal notices mailed out to our members July 1st, October 1st, January 3rd, March 3rd, and May 1st. If you (the member) pay your dues in a timely manner, but the Post delays mailing your dues to Department Headquarters in a timely manner, you will receive another renewal notice.

Example: A member receives his/her dues notice on July 1st. He/she pays the Post on July 15th, but the

Post doesn't mail the member's dues to Department until September 15th. The Department receives and processes the dues and mails the dues to National in Indianapolis by September 22nd. Process done—no more renewal notices, right? Wrong!!!

"Why does the member get another dues renewal notice on October 1st, when his/her dues are paid?"

Answer: In order to avoid receiving another renewal notice your dues must be received in Indianapolis by a certain time frame—it's called the cutoff date. Continued on Page 3, Column 1.
