Department Per Capita Dues Increase

An Ad Hoc Committee was formed to study the overall operations of the Department Head-quarters and the funding for the operations and programs. After two meetings and some extensive discussions, it was recommended that the 2008 Department Dues be increased by \$5.00 effective January 7, 2008. There has been no increase in the Department since 1994, and therefore we were able to go 13 years without a dues increase. This recommendation was brought forth to the Internal Affairs Commission who by a vote of 6:1 made the same recommendation and forwarded it to the Finance Commission for review. After close review by the Finance Commission, and a unanimous vote, it was recommended that this be made into the form of a motion and presented to the 2007 Department Convention for adoption. The report was presented to the General Assembly, motion was made to accept the report and without any further discussion, motion was passed. Therefore, any memberships being sent to Department on or after January 4, 2008 must be sent in at the new rate of \$24.50 per member.

The increase is to be allocated as follows: \$1.00 to the applicable District Revolving Account; \$1.00 to the Louisiana Legionnaire; \$.25 to Boys State/Girls State; and the balance of \$2.75 to the operating fund of the Department.

Dues Structure effective January 7, 2008 at \$24.50 per member is posted to the left. This is the amount that must be turned in for each member beginning January 4, 2008.

I PAID MY POST DUES—WHY AM I GETTING ANOTHER DUES RENEWAL NOTICE?

If you pay Examples: your dues on July 1, 2007 and want to avoid the October 1, 2007 renewal notice, you dues must be received in Indianapolis by September 12, 2007. If you pay your dues on October 1, 2007 and want to avoid the renewal notice on January 3. 2008, your dues must be received in Indianapolis by December 12, 2007. If you pay your dues on December 15, 2007 and want to avoid the renewal notice on March 3, 2008 your dues must be received in Indianapolis by February 13, 2008. If you pay your dues March 15, 2008 and want to avoid the May 1, 2008 renewal notice, your dues must be received by Indianapolis by April 9,

2008.

As you can see, any delay in the Post or Department in the membership process can lead to our members receiving another renewal notice, which will cause confusion and anger.

Therefore, I respectfully request that all Post Adjutants and/or Finance Officers attempt to transmit their membership dues to Department in a timely manner (preferably on a weekly basis). This process will cause the Post, Department and National offices less headaches and provide our members the timely service and respect they deserve.

Special Note:

Be sure to notify Department Headquarters of any changes of address of any member of your Post by completing the "Member Data Form". Of special interest are the Commander and the Adjutant. Communication from Department and National Headquarters will be provided to these individuals. All communications received from Department or National should be read by the Adjutant to keep him/her abreast of what is going on and that information should be communicated to your Post membership. Remember, any and all changes must first go through Department Headquarters for processing.

Common Questions

Q—Can a Post demand funds from a Unit for upkeep of Post Home?

A—NO. American Legion Posts and American Legion Auxiliary Units are related but independent organizations per Article XIII, Section 3 of the National Constitution of The American Legion. Except as prescribed in the above article, an American Legion Post has no authority to control the Unit related to it. The Unit is a separate entity; as such, it has its own treasury.

Q—Can membership eligibility be challenged after membership status is granted?

A—Eligibility is a condition which must exist at all times and can be challenged at any time. Once challenged, the obligation is on the challenged member to prove eligibility. If the condition of eligibility does not exist and/or the member cannot or refuses to demonstrate eligibility, the individual is not a

member of The American Legion.

Q—Can Posts have 'Associate Members'?

A—NO. Only those veterans who meet the stated membership eligibility may join The American Legion. Article IV, Section 2 of The American Legion National Constitution provides: "There shall be no form or class of membership except an active membership, and dues shall be paid annually or for life".

Q—What is the official relationship of a Post to Department?

A—Departments and Posts are autonomous, independent entities, which run their own 'day-to-day' affairs. The Department has a general oversight responsibility to the Posts in the Department but this oversight is not operational control.

Q—Is a Headquarters Post 401 member eligible?

A-Initially, a new member

under the Direct Mail Solicitation (DMS) program is assigned to the Headquarters Post 401 by providing his/her service dates and character of discharge and signed application certifying eligibility. Upon transfer to al local Post, however, the ultimate responsibility for verifying membership eligibility, using DD Form 214 or other official proof of honorable service with the U.S. Armed Forces, lies with the Post. It needs to be pointed out that of the more than 1.5 million new members acquired through the DMS program, National Headquarters has been informed of less than 100 ineligible individuals.

Q—What does 'Member in Good Standing' mean?

A—It means the member must have a valid membership card for the current Legion year. (Legion membership year runs from January 1 to December 31).
